No.1076 of 2022 pending on the file of the III Additional Metropolitan Magistrate, Ranga Reddy District at L.B.Nagar in respect to the Petitioners / A2 to A5;

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of M/s NARESH KUMAR GORIGE Advocate for the Petitioners and Public Prosecutor for the respondent No.1, directed issue of notice to the Respondent No.2, herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 16.02.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

Petition under 528 of BNSS, praying that in the circumstances stated in the grounds filed in support of the criminal petition, the High Court may be pleased to STAY all further proceedings including the appearance of Petitioners / Accused Nos. 2 to 5 in C.C. No. 1076 of 2022 pending on the file of the III Additional Metropolitan Magistrate, Ranga Reddy District at L.B.Nagar, pending disposal of CRLP No. 17504 of 2025, on the file of the High Court.

The Court made the following:

ORDER:

Notice before admission.

Learned counsel for the petitioners is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Learned counsel for the petitioners/accused Nos.2 to 5 submits that the petitioners have not committed the alleged offences and have been falsely implicated in the present case. Respondent No.2 has implicated all the family members of her husband by making omnibus allegations. Even according to the allegations made either in the complaint or in the final report, the ingredients of the offences under Section 498-A and Section 323 of the IPC, and Sections 3 and 4 of the D.P. Act, are not attracted against the petitioners. Therefore, the continuation of the proceedings against the petitioners/accused Nos. 2 to 5 is a clear abuse of the process of law.

Taking into consideration the above submissions, this Court is of the view that a detailed examination is required for adjudication of the case.

Post on 16.02.2026.

Till such time, there shall be an interim stay of all further proceedings against the petitioners/accused Nos.2 to 5 in C.C.No.1076 of 2022 on the file of the learned III Additional Metropolitan Magistrate, Ranga Reddy District at L.B.Nagar.

In default of filing proof of service of notice, the stay shall stand vacated.
