WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein, and the earlier orders dt. 31-12-2025, made the following;

ORDER:

Learned counsel for the petitioner and learned Government Pleader for Services-III are present.

Learned counsel for the Government Pleader for Services-III submits that, today he has filed dispense with petition.

Per contra, learned counsel for the petitioner submits that the said dispense with petition is filed in C.C.No.1443 of 2025, which has been complied with today.

For compliance with the order of this Court, all the matters were listed today. Out of nearly 600 cases, only three cases were complied with. The respondent neither fully complied with the order of this Court nor made any
