WHEREAS the petitioners have presented the Contempt Case under Sections 10 to 12 of the Contempt of Courts Act, 1971 under Article 215 of the Constitution of India, through their Counsel Sri K.R. Prabhakar, praying the High Court to punish the respondent authorities herein for willful, deliberate, disobedience of the order Dt. 08.07.2025/24.10.2025 passed in W.P.No.16973 of 2019 in the interest of Justice;

WHEREAS the said case coming on for hearing, and whereas the High Court, upon perusing the affidavit filed therein, and upon hearing the arguments of Sri K.R. Prabhakar, Advocate for the petitioners, made the following;

ORDER:

This Contempt case is filed complaining non-implementation of the order, dated 08.07.2025/24.10.2025 passed by this Court in W.P.No.16973 of 2019.

For the reasons stated in the accompanying affidavit, the Registry is directed to issue notice to the respondents to show cause as to why they should not be punished under the Contempt of Courts Act, 1971, for non-compliance of the aforesaid order, by filing a counter-affidavit on or before 06.02.2026, failing which, they shall appear before this Court on that date at 10:30 A.M.

It is made clear that if the counter-affidavit is not filed on the date specified, the same shall not be accepted without payment of costs of Rs.10,000/- to the Registrar (Judicial) by the respondents.
