WHEREAS the Petitioner above named through his Advocate Sri VENKATA RAGHU MANNEPALLI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order, direction particularly one in the nature of Writ of Mandamus or any other appropriate writ (i) declare the action of the Police in not registering FIR against the respondents in pursuance of petitioners written complaint dated 22-05-2017 and 27-05-2017 as illegal, arbitrary, violation of the natural justice and fundamental right guaranteed by the Constitution of India, as well as against the legal ratio laid down by the Honble Apex Court in Lalitha Kumaris Judgement and consequently may direct the Official Respondents to register the FIR against the Respondent No 7-22 in pursuance of petitioners written complaint 22-05-2017 and 27-05-2017 with an immediate effect in the interest of justice or consequently direct the Central Bureau of Investigation to register FIR and conduct fair investigation in the present criminal activity, as the Telangana state police agencies are biased to conduct fair investigation in the present Criminal activity due to involvement of higher police officials, and some politicians of Telangana state Government.
