Notification, dated 02.11.2017. It is further submitted by the learned counsel that, thereafter no action has been taken and that 24.12.2018 is the last date for OBC fellowships.

Having regard to the resolution, passed by the committee of Deans, there shall be interim direction as prayed for. However, the same shall be subject to the outcome of the Writ Petition.
