 PRAŞADA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any writ, order or direction more particularly one in the nature of Writ of MANDAMUS, declaring the action of the respondents in considering the candidature of 5th to 12th respondents for promotion to the post of School Assistant by over- looking the petitioner who is senior to the 5th to 12th respondents as arbitrary, illegal, bad in law, violative of Article 14 of the Constitution of India, also against the orders dated 11.12.2015 passed in Review M.A.No. 3543 of 2009 in O.A.No.5853 of 2002 and consequently direct the respondent Nos. 1 to 4 to promote the petitioner to

the post of Head Master Grade-II, on par with 5th to 12th respondents with effect from 17-10-2000 with all consequential and attendant benefits, by implementing the orders of the Honourable APAT dated 11.12.2015 passed in Rev.M.A.No. 3543 of 2009 in O.A.No. 5843 of 2002 .
