- 2.** Heard Mr. Punjabi, learned Advocate for Petitioners.
- 3.** Common order passed in three matters was the subject matter of challenge in Writ Petition (Stamp) No.8109 of 2026. The same was mentioned before this Court and by order dated 23.03.2026 after perusing the order dated 12.03.2026 which was a common order, this Court by giving reasons in paragraph Nos.3 and 4 stayed the same. The same common order dated 12.03.2026 is the subject matter of challenge in Writ Petition (Stamp) No.8245 of 2026 and Writ Petition
