1. Today is the National Lokadalat in respect of the Railway claims. There are 108 matters on the regular board and about 47 matters on the supplementary board at Sr. No.901. Out of these matters, there are 8 Appeals that have been filed by the Railways.

2. Mr. Pandian, learned Counsel for the Railways, on instructions, has sought to withdraw the said Appeals as the decretal amounts have already been deposited in the respective Tribunals/Courts and in respect of which separate orders of withdrawal have been passed.

3. In respect of the other matters listed on the two causelists, Mr. Mohan Rao, learned Counsel for the Claimants submits that these matters can be worked out with the Railways in view of the law settled by the Hon'ble Supreme Court in the case of **Union of India Vs. Rina Devi; (2019) 3 SCC 572** and other matters.

4. Mr. Pandian, learned Counsel for the Railways would

submit that though these matters can be worked out in view of the settled law, however, despite persistent efforts, he has been unable to persuade the Railway Authorities for giving consent for entering into the Consent Terms with the claimants, though otherwise he submits that these matters are fit to be settled in a Lokadalat.

5. Our attention has been drawn to a communication dated 16th November 2020 from the Railway Board, Ministry of Railways to all the Principal Chief Commercial Managers, All Indian Railways which encloses a letter dated 5th March 2018 to the Registrar, Railway Claims Tribunal communicating the decision to authorise various Railway Claims Tribunals to coordinate with National, State or District Legal Services Authorities to organise Lokadalat for various categories of claims which include admitted cases of untoward incidents, execution of petition for compliance of decree in favour of claimant, claims under Section 124, refund of freight and compensation for loss, damage, deterioration, destruction and non-delivery of goods. The said communication in detail suggests how the claims can be settled through Lokadalat by way of compromise for

expeditious settlement of disputes.

6. In this view of the matter, we would recommend that similar directions can be issued in respect of the first appeals pending before the High Court duly authorising the railway officials to enter into compromise/consent terms similar to the directions contained in the communication dated 5th March 2018.

7. Mr. Ravindra Joshi, Deputy Chief Commercial Manager (Claims), Western Railway, Mumbai and Laxmikant H. Sawardekar, Chief Law Assistant, Central Railway, Mumbai are also present in the Lokadalat.

8. Hence, at the request of learned Counsel for the claimants as well as Railways and their officers, these Appeals be placed before the next Lokadalat, so that the same can be expeditiously settled.
