1. The Anticipatory Bail Application and the Intervention Application filed in the same are listed today.

2. The Intervenors seeking intervention in Anticipatory Bail Application No. 1089 of 2026 are present in Court. They state that they wish to address the Court in-person. They further state

Consequently, the Applicant in Anticipatory Bail Application No. 1089 of 2026 is directed to amend the cause title by adding Shri Uday Jayawant Jadhav and Shri Unmesh Jaywant Jadhav as Intervenors in the Anticipatory Bail Application No. 1089 of 2026.

7. Mr. Kunal Kumbhat, learned Advocate for the Applicant seeks permission to carry out the amendment forthwith. Permission granted.

8. Interim Application (ST) No. 9216 of 2026 is disposed of.
