ORDER :

1. Learned Advocates for the parties submit that it is common ground that the terms of the Permanent Alternate Accommodation Agreement (“*PAAA*”) have been agreed upon. The only gap between them appears to be a demand for a confirmation of what is the final sanctioned plan. Mr. Jan Learned Advocate on behalf of Alleged Contemnor, tenders across the Bar, a copy of the Occupation Certificate, to which the sanctioned plan is annexed. The same is marked “X” for identification and taken on record.
2. Since it is assured that what is tendered across the Bar today constitutes the final accurate sanctioned plan, even this concern expressed by the Petitioners would stand allayed. Petitioners are at liberty to take inspection and copies of the same from the Registry.
3. It is also stated that in Contempt Petition No. 180 of 2009, the original Petitioner, D. Rajamani, has passed away, and therefore Interim Application No. 17950 of 2022 is filed to bring on record Mrs. Pushpa Iyer, as a Petitioner in his place. A copy of the amendment is tendered across the bar and marked “X-1” for identification and taken on record. Liberty is granted to effect the changes before the Registry. Re-verification is dispensed with. Accordingly, Interim Application No. 17950 of 2022 is *disposed of*.

4. It is also agreed between the parties that the registration of the Permanent Alternate Accommodation Agreement ("**PAAA**") will be executed within a period of four weeks from today and appropriate appointments before the Sub-Registrar's Office shall be taken. With the execution of the PAAA and the sanctioned plans having been taken on record, in substance, the Contempt Petition would be expected to be worked out.

5. To ascertain compliance, stand over to ***June 9, 2026***.

6. All actions required to be taken pursuant to this order shall be taken upon receipt of a downloaded copy as available on this Court's website.
