1. At the outset, learned Counsel for the applicant seeks leave to add the original complainant as party respondent No.2. Leave

granted. Amendment to be carried out forthwith.

2. Heard learned Counsel for the parties.

3. There appears to be matrimonial disputes between husband and wife out of which several complaints are filed. There also appears to be a case of cross complaint. Both the parties are educated and affluent families. Both the parties to approach the Mediation Centre of this Court on **20th May, 2026 at 11.00 a.m.**, after which, the Mediator to give dates convenient to him and the parties. The parties, through their respective Counsel assure to extend full co-operation during mediation.

4. Mediator to submit his report on the next date.

5. Copy of this order be forwarded to the Co-ordinator, High Court Mediation Centre, Mumbai, for information and necessary action.

4. Stand over to **24th June, 2026.**

5. Pending the Mediation, in the meantime, till the next date, the applicants are granted interim protection on the following terms and conditions :

ORDER

(i) **In the event of arrest, the applicant – Nisha Jitendraa Siingh, shall be released on bail in connection with C.R.No.7 of 2026 registered with Koregaon Park Police Station, Pune City, on 11th January, 2026, for the offences punishable under Sections 316(2), 318(4), 351(3), 305, 314, 61 r/w 3(5) of the Bharatiya Nyaya Sanhita, 2023 and Section 4 of the Maharashtra Prevention and Eradication of Human Sacrifice and other Inhuman, Evil and Aghori Practices & Black Magic Act, 2013, on furnishing P.R. bond in the sum of Rs.25,000/-, with one or two solvent sureties in the like amount;**

(ii) The applicant shall report to the Investigating Officer of the concerned Police Station once in a week i.e. on every Monday from 11.00 a.m. to 2.00 p.m.
