MINUTES OF THE ORDER

1. It is ~~been~~ agreed between both the parties that the all disputes between the parties are settled. The Applicant shall make a total payment of Rs.40,00,000/- (Rupees

Forty Lakh Only) to the Respondent as recorded hereinbelow.

2. The Applicant shall make a payment of Rs.17,00,000/- (Rupees Seventeen Lakh Only) through Demand Draft to the Respondent drawn in favour of "Aishwarya Sanjay Deshmukh" on the date of withdrawal of PWDVA No. 463 of 2023 before the Ld. J.M.F.C Nashik. *This will happen simultaneously.*

3. Applicant shall make the payment of Rs.8,00,000/- (Rupees Eight Lakh Only) through Demand Draft drawn in favour of "Aishwarya Sanjay Deshmukh" in the Family Court – 02, Nashik at the time of grant of Divorce Decree through mutual Consent in Petition A636 of 2023 before the Ld. Family Court – 02 Nashik. Both parties shall endeavour to procure the Divorce Decree and withdrawal of PWDVA No. 463 of 2023 on or before 27/03/2026.

4. The Applicant shall deposit Rs.5,00,000/- (Rupees Five Lakh Only) on or before 27/03/2026 and Rs.5,00,000/- (Rupees Five Lakh Only) on or before 27/04/2026 before the Ld. Registrar, Appellate Side, Bombay High Court.

5. The Respondent shall hand over the Original Consent Affidavit granting her Consent for Quashing of FIR being C.R. No. 256 of 2023 lodged at the Gangapur Road Police

Station, Nashik and consequential Chargesheet and R.C.C. No. 676 of 2025 pending on the file of Hon'ble J.M.F.C. Nashik titled as "*State of Maharashtra Versus Anil Chavan & Anr.*" within one week of the Applicant depositing the second instalment before the Hon'ble Bombay High Court as above.

6. The Applicant shall make a payment of Rs.5,00,000/- (Rupees Five Lakh Only) through Demand Draft in the name of "*Aishwarya Sanjay Deshmukh*" to the Respondent on the date of Order of Quashing of FIR No. 256 of 2023 lodged with the Gangapur Road Police Station, Nashik and R.C.C. No. 676 of 2025 pending before the Hon'ble J.M.F.C. Nashik.
7. After the Quashing of the above proceedings, Respondent shall then withdraw the amount of Rs.10,00,000/- (Rupees Ten Lakh Only) deposited before Ld. Registrar, Appellate Side, Bombay High Court.
8. The Parties agree confirm and declare that no other proceedings are initiated or pending between the parties against each other and / or against the opposite party's families.

9. Parties confirm and declare and undertake before this Hon'ble Court that they shall not initiate any further proceedings arising out of their marital and contractual / business relationship.


10. Both the parties declare that all claims against each other are fully settled and no further claims allegations / insinuations shall be made by the parties against each other.
