Therefore, by virtue of Rule 3 sub rule (iii) of Chapter XVII of the Rules 1960, the aforesaid Writ Petitions are listed on the board of Registrar (Judicial-I).</p> <p>Sub-rule (iii) of Rule 3 of Chapter XVII provides that if office objections are not removed, after notifying the same under Rule 3 sub rule (ii), the Registrar shall refuse registration of the matters.</p>
