6. Mr. Mukerji informs the Court that due to reasons which are stated in the praecipe and personal difficulty and exigency expressed by him due to change of the law firm, the said amendment remained to be carried out on behalf of Petitioner.

7. I am inclined to accept the reasons given by Mr. Mukerji and condone the delay and extend the time to carry out the amendment which is allowed by order dated 24.06.2025.

8. Mr. Mukerji in his usual fairness also informs the Court that because the said amendment was not carried out, Respondent No.2 has filed Interim Application seeking dismissal of present Petition on that ground.

9. That Interim Application shall be heard on the next adjourned date alongwith the Writ Petition.
