2. In the meantime, parties are at liberty to resolve their disputes amicably.
3. Learned Advocate for the petitioner states that the petitioner shall deposit the amount as directed by the impugned Award within four weeks from today. Hence, within four weeks from today, the petitioner shall deposit amount as directed in the impugned Award in this Court.
4. On deposit of such amount, there shall be ad-interim relief in terms of prayer clause (b) till 20 February 2026.

5. Stand over to **20 February 2026**.
6. It is clarified that till 20 February 2026, no coercive steps shall be taken in the criminal proceedings initiated against the petitioner.
