ORDER :

3. As regards Commercial Suit No.111 of 2025, that too entails Interim Application (L) No.19280 of 2024 for interim relief and Interim Application (L) No.7649 of 2025 filed by the Defendants seeking

rejection of the claims using the summary procedure under Order XIII-A of the Civil Procedure Code, 1908 as amended by the Commercial Courts Act, 2015. Rejoinder if any, in Interim Applications filed in Interim Application (L) No.19280 of 2024 shall be filed no later than March 16, 2026.

4. Likewise, the reply to Interim Application No.7649 of 2025 shall be filed no later than March 16, 2026. The replies referred to in the order dated February 12, 2026 shall also be filed by March 16, 2026.

5. Rejoinder, if any, in Interim Application No.5144 of 2025 is permitted to be filed with the Registry. Liberty to also bring on record an affidavit with additional facts and subsequent developments as contained therein by the Advocate for the Applicant.

6. List under the caption “*For Directions*” on *April 1, 2026*. Ad-interim arrangements obtaining as of today shall continue until the next date.
