1. These are transferred proceedings from the Intellectual Property Appellate Board (IPAB). Due to change in law and winding up of the IPAB, these proceedings originally filed before the IPAB have been transferred and numbered as commercial miscellaneous petitions in this Court.

2. These petitions were listed before the Prothonotary and Senior Master of this Court for complying with office queries on 04th March 2025. On the said date, the Prothonotary and Senior Master of this Court passed an order granting time of four weeks from the date of the of uploading of the said

3.
