1. We have perused the order dated 10th May 2024, wherein a specific direction was issued to the Municipal Corporation to take action against the offending structure in accordance with law. We have perused the Affidavit filed by the Municipal Corporation dated 4th November, 2024 and the Compliance Report shown to us by tendering a document dated 15th January, 2025 across the bar.

2. Little has been done by the Municipal Corporation. The fact remains that the offending structure is still untouched by the Municipal Corporation. We could have issued *suo moto* contempt notice to the Commissioner of the Municipal Corporation. However, the learned Advocate for the Corporation submits that a date and sequence-wise ready reference chart of what steps were taken after 10th May, 2024 in a concise form, supported with an

Affidavit (in short a Flow Chart) would be filed in this Court within a week's time. We are, therefore, inclined to grant her time.

3. Let the aforesaid Flow Chart with a short Affidavit be tendered in the Court, on or before 26th September, 2025.

4. List these Petitions on **3rd October, 2025** in the “**Urgent**” Category.

5. We make it clear that we will not adjourn the proceedings on the pretext that any of the parties have entered a leave note.
