This Third Party Application has been filed by Amit Vilas Dabholkar, Third Party Applicant, seeking certified copies of the entire papers and proceeding of Testamentary Suit No. 72 of 2003 including Will of Ms. Yamuna Govind Dabholkar and Orders dated 17th February 2009, as per Rule 268 of the Bombay High Court Original Side Rules 1980.

2. Third Party Application has been served upon the parties to the Testamentary Suit and the affidavit of service dated 9th April, 2026 is on record. None present on behalf of the parties to the Testamentary Suit.

3. Perused the affidavit in support and additional affidavit. The Applicant stated in the additional affidavit that, property bearing City Survey No. F/1277, F/1278, F/1279 and F/1280 were purchased by the great grandfather of the Applicant by Purchase Deed dated 22nd August 1928. IT is further stated that, the great grandfather Govind Narayan Dabholkar expired in the year 1957 and his legal heirs were brought on record. It is further stated that, additional affidavit that Vilas Narayan Dabholkar father of the



Applicant passed away on 4th March 2019 leaving behind the Applicant and his brother. It is further stated that, his mother Mrs. Lalita Vilas Dabholkar passed away prior to his father on 17th January 2018 without making a Will and the said properties is personally undivided. The Applicant has stated that, he requires the certified copies of the Testamentary Suit for the purpose of producing before the statutory authorities for the purpose of mutation entry. He therefore requested to issue three certified copy of the entire papers and proceedings of the Testamentary Suit No. 72 of 2003 in Testamentary Petition No. 733 of 2002.

4. It is to be noted that Rule 268 of Bombay High Court Original Side Rules, 1980, indicates that if sufficient cause is shown, this Authority has discretion to grant certified copy of the entire papers and proceeding of Testamentary Suit No. 72 of 2003 including Will of Ms. Yamuna Govind Dabholkar and Orders dated 17th February 2009 to the Third Party Applicant.

6. For the reasons stated in the affidavit in support the Third-Party Application is allowed. Office is directed to issue three set of certified copies of entire papers and proceeding of Testamentary Suit No. 72 of 2003 including Will of Ms. Yamuna Govind Dabholkar and Orders dated 17th February 2009 to the third party applicants as per the application, on payment of necessary charges.

7. It is made clear that the third party applicant shall use the certified copy only for the purpose mentioned in the Third Party Application and in accordance with Rule 271 of Bombay High Court
