- 1.** Not on Board mentioned by way of filling a praecipe dated 09.04.2026, perused the praecipe.
- 2.** Heard Mr. Kadu, learned Advocate for Petitioners.
- 3.** Present Misc. Petition is filed by Petitioners for issuance of legal heirship certificate under Section 2 of Bombay Regulation VIII of 1827 in respect of the properties and credits of deceased Vithabai Keshav Jadhav alias Vithabai K. Jadhav alias V.K. Jadhav alias Vittabai Keshav Jadhav. The names and details of legal heirs of the deceased are stated in paragraph No.4 of the Petition. Purpose for filing the present Petition is stated in paragraph No.11 of the Petition. I have perused the same.
- 4.** Petitioners are the only legal heirs of the deceased.



5. In view of the above, there can be no impediment in allowing the Petition. Misc. Petition is allowed and disposed of in terms of prayer clause 'a' which reads thus:-

"a' This Hon'ble Court be pleased to issue a Legal Heirship Certificate to the petitioners under the provisions of Bombay Regulation Act VIII of 1827 certifying that the petitioners viz. (1) SAGAR VASANT JADHAV, grandson (2) BABURAV KESHAV JADHAV, son (3) PANDURANG KESHAV JADHAV, son (4) MARUTI KESHAV JADHAV, son (5) SUNANDA SHIVAJI GHOTANE, married daughter (6) MANGAL VASANT JADHAV, widowed daughter-in-law (7) ASHWINI SANTOSH CHAVHAN , granddaughter (8) LAXMI ASHOK JADHAV , widowed daughter-in-law and (9) OMKAR ASHOK JADHAV, grandson are the legal heirs and legal representatives of the deceased viz. VITHABAI KESHAV JADHAV alias VITHABAI K. JADHAV alias V.K. JADHAV alias VITTABAI KESHAV JADHAV "

6. Issuance of proclamation stands dispensed with.
7. Department is directed to issue the legal heirship certificate as directed above within a period of 3 weeks from today positively.
8. Misc. Petition is allowed and disposed subject to compliance of office objections, if any, forthwith which shall be allowed by the Department. It is clarified that the 3 week period shall start from the date of removal of office objections.
9. Praecipe is disposed.
