1. When the matter is called out, Ms. Rajpurohit, learned Counsel appears for the Plaintiff and submits that the matter has been settled in terms of the Settlement Agreement dated 23rd April, 2026 and therefore, the Plaintiff is desirous of withdrawing the Suit.
2. Learned Court Associate has also tendered across the bar a certification dated 29th April, 2026 as at 10.42 a.m. of the Section Officer of the Execution Department of this Court that there is no caveat against the release of the Defendant-Vessel.
3. Mr. Ghosh, learned Counsel appearing for the Defendant-Vessel has no objection if the Suit is allowed to be withdrawn.

4. Having heard the learned Counsel and having considered the submissions, the order of arrest dated 15th April, 2026 is vacated and the Defendant-Vessel viz. Ro Ro Cargo Ship Adler, IMO No. 9179854 is released and is allowed to sail, subject to other arrests or caveats.
5. The Sheriff of Mumbai is directed to take necessary steps to release of the Defendant-Vessel.
6. The Sheriff's poundage and any other costs associated with the release shall be borne by the Plaintiff.
7. The formal instrument of release is dispensed with.
8. The Commercial Admiralty Suit (L) No. 1307 of 2026 is allowed to be withdrawn and is disposed of as such.
9. Refund of Court fees as per Rules. For the purpose of Section 43 of the Maharashtra Court Fees Act, 1959 and the proviso to that Section, today's date is the date for making a claim for repayment. The Prothonotary & Senior Master will issue a certificate for refund of Court fees computed according to the Rules and act on production of an authenticated copy of this order without requiring a separate application.

10. The Plaintiff to serve this order by email/post/courier/hand delivery upon the Sheriff, Master of the Vessel and to the Ship owner and upon the relevant Port and customs authority at its own costs.

11. All concerned including the Sheriff of Mumbai, the Port and customs authorities and other authorities to act on a copy of this order duly authenticated by the learned Associate of this Court.
