*(d) That this Hon'ble Court be pleased to permit substitution of the name of Original Applicant no.1 in IA No.4611/2025 as “R M Bhuther And Company Limited through Resolution Professional Gajesh Labhchand Jain”;*

*(e) That this Hon'ble Court be pleased to permit substitution of the name of Original Respondent no.2 in IA No.4830/2025 as “R M Bhuther And Company Limited through Resolution Professional Gajesh Labhchand Jain”;*

*(f) That this Hon'ble Court be pleased to permit substitution of the name of Original Respondent no.1 in IA(L) No.37274/2025 as “R M Bhuther And Company Limited through Resolution Professional Gajesh Labhchand Jain”;*



*(g) That this Hon'ble Court be pleased to permit consequential amendment in the cause title and pleadings of the Commercial Execution Application No.43 of 2023 and IA No.3246/2025, IA/3625/2025, IA/4611/2025, IA/4830/2025 & IA(L)/37274/2025.”*

4. Let the amendments be carried out within a period of two weeks and the amended proceedings be served within a period of two weeks thereafter and an appropriate Affidavit of service be filed.
