This Third Party Application has been filed by Prashant Kumar Pandey, Third Party Applicant, seeking certified copies of the Order dated 12th August 2010 passed by this Hon'ble Shri Justice R.Y. Ganoo, as per Rule 268 of the Bombay High Court Original Side Rules 1980.

2. Third Party Applicant submits that, a Third Party Application (L) No. 8958 of 2026 filed by him was sent for service upon the parties to the Writ Petition was returned by Postal Authority with remark "No such person" and the affidavit of service dated 4th April, 2026 was filed in that Third Party Application. He prays that, the service of the Third Party Application be dispensed with.

3. Service of Third Party Application upon the parties of the Writ Petition is dispensed with. Perused the affidavit in support. The Applicant stated in the affidavit that, he is son of Defendant No. 2 viz. Babulnath Pandey who is expired. He further submits that, as per Order dated 12th August 2010 passed by this Hon'ble Court, the Plaintiff was directed to deposit the money in this Hon'ble Court and he is not aware whether the money has been deposited or not.



He further submits that, the certified copy of the Order is required for the purpose of taking necessary steps in the matter. He further submits that, Third Party Application (L) No. 8958 of 2026 filed by him was allowed by an Order dated 8th April, 2026 but the date of order for certified copy was incorrectly mentioned therefore, he did not get certified copy. He further submits that, the correct date of Order of which the certified copy is required is 12th August 2010. He, therefore, prays that, the Third Party Application be allowed and the certified copy of the Order dated 12th August 2010 be issued for the purpose of taking further steps.

4. It is to be noted that Rule 268 of Bombay High Court Original Side Rules, 1980, indicates that if sufficient cause is shown, this Authority has discretion to grant certified copy of the Order dated 12th August 2010 to the Third Party Applicant.

5. For the reasons stated in the affidavit in support the Third-Party Application is allowed. Office is directed to issue certified copies of Order dated 12th August 2010 passed by this Hon'ble Court to the third party applicants as per the application, on payment of necessary charges.

6. It is made clear that the third party applicant shall use the certified copy only for the purpose mentioned in the Third Party Application and in accordance with Rule 271 of Bombay High Court O.S. Rules, 1980, and not to part with the certified copy to any other third party. Third Party Application is disposed of.
