3. Present Misc. Petition is filed by Petitioner for issuance of
legal heirship certificate under Section 2 of Bombay Regulation VIII of
1827 in respect of the properties and credits of deceased Anant
Krishnarao Deshmukh alias Anant K Deshmukh alias Anant Deshmukh
alias Anant Krishnaji Deshmukh alias A. K. Deshmukh alias Anant
Krishna Deshmukh alias Annat Krishnarao Deshmukh alias Anant



Krishwarao Deshmukh alias Ananth K Deshmukh and Anuradha Anant Deshmukh alias Anuradha A. Deshmukh alias Anvaradha Anant Deshmukh. The names and details of legal heirs of the deceased are stated in paragraph No.5 of the Petition. Purpose for filing the present Petition is stated in paragraph No. 15 of the Petition. I have perused the same.

4. Consent affidavit dated 25.04.2026 of Krishna Anant Deshmukh and Anjani Suhas Lonakadi, the legal heirs are filed on record and appended at page Nos. 61 and 65 of Petition.

5. In view of the above, there can be no impediment in allowing the Petition. Misc. Petition is allowed and disposed of in terms of prayer clause 'a' which reads thus:-

"a) This Hon'ble Court be pleased to issue a Legal Heirship Certificate to the Petitioner under the provisions of Bombay Regulation VIII of 1827 certifying that (I) the Petitioner viz. Vinod Anant Deshmukh (son) alongwith (ii) Krishna Anant Deshmukh (son) and (iii) Anjani Suhas Lonakadi (daughter) are the only heirs and legal representatives of the said Deceased No. 1 viz. Anant Krishnarao Deshmukh alias Anant K Deshmukh alias Anant Deshmukh alias Anant Krishnaji Deshmukh alias A. K. Deshmukh alias Anant Krishna Deshmukh alias Annat Krishnarao Deshmukh alias Anant Krishwarao Deshmukh alias Ananth K Deshmukh and Deceased No.2 viz. Anuradha Anant Deshmukh alias Anuradha A. Deshmukh alias Anvaradha Anant Deshmukh."

6. Issuance of proclamation stands dispensed with.

7. Department is directed to issue the legal heirship certificate as directed above within a period of 3 weeks from today positively.



8. Misc. Petition is allowed and disposed subject to compliance of office objections, if any, forthwith which shall be allowed by the Department.
