- 2.** Heard Mr. Inamdar, learned Advocate for Petitioner.
- 3.** Present Misc. Petition is filed by Petitioner for issuance of legal heirship certificate under Section 2 of Bombay Regulation VIII of 1827 in respect of the properties and credits of deceased Vithal Shankar Manchekar. The names and details of legal heirs of the deceased are stated in paragraph No. 4 of the Petition. Purpose for filing the present Petition is stated in paragraph No. 7 of the Petition. I have perused the same.
- 4.** Consent affidavits dated 25.03.2026 of Madhavi Milind Manchekar, Rushikesh Milind Manchekar, Sakshi Milind Manchekar,



Sapna Suresh Mondkar nee Sulbha Vithal Manchekar, Raghunath Vithal Manchekar, Santosh Vithal Manchekar and Priya Sitaram Chawan nee Priya Vithal Manchekar, the legal heirs are filed on record and appended at page Nos. 33, 38, 43, 48, 53, 58 and 63 of Petition.

5. In view of the above, there can be no impediment in allowing the Petition. Misc. Petition is allowed and disposed of in terms of prayer clauses 'a' and 'b' which read thus:-

- "a) *This Hon'ble Court be pleased to condone the delay in filing the present Petition.*
- b) *That a Legal Heirship Certificate be issued under the provision of Bombay Regulation Act VIII of 1827, certifying that (1) Vishnu Vithal Manchekar, (2) Madhavi Milind Manchekar, (3) Rushikesh Milind Manchekar, (4) Sakshi Milind Manchekar, (5) Sapna Suresh Mondkar, (6) Raghunath Vithal Manchekar, (7) Santosh Vithal Manchekar and (8) Priya Sitaram Chavan are the only legal heirs and legal representatives of Deceased- Vithal Shankar Manchekar."*

6. Issuance of proclamation stands dispensed with.

7. Department is directed to issue the legal heirship certificate as directed above within a period of 3 weeks from today positively.

8. Misc. Petition is allowed and disposed subject to compliance of office objections, if any, forthwith which shall be allowed by the Department. It is clarified that the 3 week period shall start from the date of removal of office objections.
