The question as to whether sales tax will be payable on the sale of electricity by the generating companies to its captive consumers is subjudice before this Court in a batch of Writ Petitions including, inter alia, Writ Petition No. 9993 of 2026; Writ Petition (L) No. 10423 of 2026; Writ Petition (L) No.10424 of 2026 and Writ Petition (L) No. 10533 of 2026.

2. The learned Counsel for the Petitioners submit that since the same issue is involved in the present Writ Petitions, the matters be tagged along with the pending Writ Petitions and similar interim order/s be passed protecting the Petitioners pending the disposal of the Writ Petitions.

3. We have perused the said interim order/s. The learned AGP appears for Respondent no.1 and seeks some time to file a reply.
4. Issue notice to the Respondents, returnable in four weeks.
5. Learned AGP waives notice on behalf of Respondent no.1. Court notice be issued to the remaining Respondents. The Petitioners shall supply a copy of the present Writ Petitions to the Registry for issuance of notice.
6. Let these matters be tagged along with the batch of Writ Petitions that are subjudice before this Court and which raise a similar question of law.
7. Having regard to the facts and circumstances of the case and the issue involved in the present Writ Petitions, we make it clear that the ad-interim order operating in the batch of Writ Petitions that are pending before this Court of protection, shall also apply to the present Writ Petitions.
9. A copy of the present Writ Petitions be served on the learned Addl. Govt. Pleader.
10. Stand over to **9<sup>th</sup> July 2026**.
