1) Mr. Bhushan Mahadik, learned Counsel appears on behalf of Respondent no. 3, and, on instructions, makes a statement that Respondent no. 3 will make payment to JBCN International School, Oshiwara in respect of his two daughters viz. Ms. Saisha Nikunj Patel

and Ms. Shanaya Nikunj Patel towards the outstanding fees for the academic year 2025-26 and towards cafeteria fees for the academic year 2026-27. The amounts are as under:

(i) Rs. 2,98,374/- + Rs. 60,000/-

(ii) Rs. 2,99,299/- + Rs. 60,000/-

(iii) Rs. 20,700/- + Rs. 53,950/-

(iv) Rs. 20,700/- + Rs. 53,950/-

2) Respondent no. 3 undertakes that this payment shall be made to the school no later than 5th June 2026 and proof of this payment shall thereafter be forthwith furnished to the Petitioner. Additionally, an Affidavit of compliance will be filed before this Court.

3) The Petitioner states that in addition to the aforesaid fees, there are also arrears in respect of fees towards the first quarter of 2026-27 that is required to be paid by Respondent no. 3. The Petitioner shall furnish some documentary evidence to that effect quantifying the exact amount of fees remaining outstanding after taking into consideration the amount that is stated to have already been paid by Respondent No. 3 towards the fees of the first quarter (2026-27).

4) Stand over to 15th June 2026 for recording compliance. The

Petitioner shall send this communication forthwith, so that Respondent No. 3 can make arrangement to make payment of the said arrears.
