- 1.** Not on Board. Mentioned by way of filing praecipe dated 24.03.2026. Perused the praecipe.
- 2.** Heard Mr. Bane, learned Advocate for Applicant and Ms. Pawar, learned Advocate for Petitioner.
- 3.** By way of composite order dated 18.06.2025, Interim Application (Lodging) No.8899 of 2025 stands disposed of as rejected

in view of non-compliance of Rule 986 of the High Court Original Side Rules, 1980. Interim Application (Lodging) No.9951 of 2026 is filed for setting aside of the said order. There is delay of three days and reasons are given in paragraph Nos.4 to 6. *Prima facie* after going through the said reasons, this Court finds that said reasons are believable.

**4.** Ms. Pawar, learned Advocate appears for Petitioner. She would submit that the reasons are not satisfactory. However I do not agree with the same.

**5.** Be that as it may, Interim Application deserves to be allowed in the interest of justice. Interim Application (Lodging) No.9951 of 2026 stands allowed in terms of prayer clauses (a) and (b).

**6.** Interim Application (Lodging) No.8899 of 2025 stands restored to the record and file of the Court. The objection shall be removed within a period of one week from today as assured by Mr. Bane.

**7.** Once the same are removed, Interim Application (Lodging) No.8899 of 2025 shall be proceeded further strictly in accordance with law.

**8.** In view of Interim Application (Lodging) No.8899 of 2025 having been restored, Caveat (Lodging) No.25462 of 2024 stands

restored but Applicant will have to make appropriate Application for proceeding with the Caveat in accordance with law.

**9.** With the above directions, Interim Application (Lodging) No.9951 of 2026 is disposed.
