1. Today 390 petitions have been listed third time. All the matters are fixed for passing appropriate order as office objections were not removed, despite granting ample time as per rules provided under the Bombay High Court Appellate Side Rules, 1960. The learned advocates have marked their presence in majority of the matters. They submit that they will remove the office objections, if they are accommodated by granting some time.

2. Having considered the fact that the learned advocates are ready to remove the office objections, it would be just and proper to give one more opportunity instead of refusing the registration on technical ground. It is always better to decide the lis on merit than the technicalities.

3. Having considered the common request, three weeks time is granted as sought. It is clarified that no further extension



will be granted. In turn, the following order would meet the ends of justice.

ORDER

Three weeks time is granted to remove the office objections. On failure to remove the office objections within three weeks, registration would stand refused automatically without further reference to the Court of Registrar (Judicial).
