1. None present. The above numbered batch of First Appeals/Cross-Objections/Cross Appeals/ Family Court Appeals came to be listed third time on the board of Registrar (Judicial). All the matters came to be filed in the year 2021. About one year has been lapsed, however, no steps are taken to remove the office objections.

2. It depicts from the record that all the objections were notified. Thereafter also no steps have been taken. In turn, the matters were listed on the board of Registrar (Judicial) for first time and three weeks time was granted. However, again no steps were taken. Consequently, matters listed second time, but no steps are taken to remove objections. Despite it, again in the interest of justice, two weeks time was granted. In this way, total five weeks

time came to be granted till today.

3. To my mind, five weeks time plus pendency of these matters for about one year to remove the office objections is sufficient indicator to infer that the appellants/petitioners are not willing to remove the office objections and proceed with these matters. In this scenario, it would be just and proper to refuse the registration instead of keeping it pending unnecessarily.

4. However, instead of passing stringent order outrightly, I am of the considered view to give one more opportunity subject to conditions. In turn, the following order would meet the ends of justice.

ORDER

Two weeks time is granted to remove the office objections. On failure to remove the office objections within two weeks, registration would stand refused automatically without further reference to the Court of Registrar (Judicial).
