2. The learned counsel for the claimants submits that in order dated 4.5.2026 in title clause of Arbitration Appeal No. 10/2025 respondent

No. 6 – Shrimati Shakuntala Tanhaji Patil is erroneously added before this Court. The learned counsel for respondent NHAI authority submits that respondent No. 6 is not the respondent in a proceeding before District Court as well as in a proceeding of arbitral award. The learned counsel therefore seeks permission to delete respondent No. 6 from the array of respondents in Arbitration Appeal No. 10/2025. In view of the request made, permission is granted to delete respondent No. 6 – Shrimati Shakuntala Tanhaji Patil from the array of respondents in Arbitration Appeal No. 10/2025.

3. The learned counsel for claimants also submits that in order dated 4.5.2026 in para 12 in line Nos. 1 and 2, instead of words ‘section 3(G) (7) of National Highways Act’, the words ‘Section 26 of Acquisition Act, 2013’ are wrongly typed.
