PER COURT :

1. Issue notice to the respondents, returnable on 25.06.2026.
2. The learned APP waives service of notice for the respondents-State.
3. The learned Counsel Mr. Inamdar h/f Mr. Kazi for the applicants submits that the applicants are falsely implicated in the present crime. The First Information Report is registered against one co-accused Matin Kureshi and not against the applicants. and the applicants are later on added only on the suspicion. Applicant No. 1 is a teacher in a School, whereas, applicant No. 2 is serving

as Peon in the same School. The applicants are not having any criminal antecedents and are ready to abide any conditions that may be imposed by this Court, hence the applicants may be protected.

4. The learned APP strongly opposed the application and requested to reject the application.

5. The article is already recovered from the custody of the co-accused and nothing remains to be recovered from the applicants and the applicants are also not having any criminal antecedents and is ready to abide any conditions that may be imposed by this Court, hence taking into consideration the aforesaid submissions, I am inclined to protect the applicants till the investigation papers are received. Hence the following order :

ORDER

(a) In the event of arrest of the Applicants – Museeboddin S/O Mohziboddin Quazi and Mutayyibuddin s/o Mahazibuddin Quazi in connection with Crime No.229 of 2026 registered with Nanalpeth Police Station, District Parbhani for the offences punishable under Sections 5 5-C, 6, 9 9A of the Maharashtra Animal Preservation Act, 1976, they be released on bail on furnishing P.R. bond of Rs.50,000/- (Rupees Fifty Thousands) each

with two solvent sureties each in the like amount, on the following conditions :

(i) The Applicants are directed to attend Nanalpeth Police Station, District Parbhani on every Sunday in between 11.00 a.m. to 01.00 p.m. and co-operate with the Investigating Officer, until further orders.

(ii) The Applicants shall not tamper with the evidence and shall appear before the Investigating Officer as and when required, apart from the days already mentioned above.

(iii) The Investigating Officer shall make the investigation papers available for perusal of this Court.

6. Stand over to 25.06.2026.
