1. Heard.

2. Issue notice to respondents, returnable on 29.07.2026.

Learned AGP waives notice for respondent nos.1 and 2.

3. In addition to regular mode, petitioners shall be at liberty to serve private respondents by any alternate mode as permissible under and file affidavit of service by returnable date.

4. Mr. Mukul Kulkarni, learned advocate appearing for petitioners submits that respondents instituted proceeding under Section 28A of Land Acquisition Act based on common judgment and award passed by Reference Court in L.A.R. No.11 to 66 of 2011 in which interest under Section 28 was granted from the date of possession. The petitioners preferred appeal raising challenge to award passed in L.A.R. No.11 to 66 of 2011 before this Court, wherein judgment of Reference Court has been modified and now interest is payable from the date of award instead from the date of possession. He would submit that respondents have secured impugned awards under Section 28A on the basis of award passed by Reference Court, which is now modified by this Court while allowing first appeals of petitioner.

5. In light of submissions advanced, till returnable date, there shall be ad-interim relief in terms of prayer clause (B) in tune with modification made by this Court in appeal.
