1. None present. The above numbered batch of Civil Applications/Writ Petitions/PILs came to be listed third time on the board of Registrar (Judicial). All the matters came to be filed in between 2016 to 2021. More than one year has been lapsed, however, no steps are taken to remove the office objections.

2. It depicts from the record that all the objections were notified. Thereafter also no steps have been taken. In turn, the matters were listed on the board of Registrar (Judicial) for first time and three weeks time was granted. However, again no steps were taken. Consequently, matters listed second time, but no steps are taken to remove objections. Despite it, again in the interest of justice, two weeks time was granted. In this way, total five weeks time came to be granted till today.

3. To my mind, five weeks time plus pendency of these matters for more than one year to remove the office objections is sufficient indicator to infer that the applicants/petitioners are not willing to remove the office objections and proceed with these matters. In this scenario, it would be just and proper to refuse the



registration instead of keeping it pending unnecessarily.

4. Though already ample time has been granted still due to present situation as a result of COVID-19, it would not be just and proper to pass stringent order. However, at the same time, it is also necessary to see that all these writ petitions which are pending from minimum more than one year, the objections therein needs to be removed on priority. Having regard to aforesaid aspects, the following order would meet the ends of justice.

ORDER

Four weeks time is granted to remove the office objections. On failure to remove the office objections within four weeks, registration would stand refused automatically without further reference to the Court of Registrar (Judicial). It is also clarified that in case the learned advocate is unable to attend the Court within span of four weeks and remove the office objections, then liberty is granted to mention the matter before Registrar (Judicial) within four weeks.
