**PER COURT :**

1. Heard.

2. The learned Counsel for the petitioners/ claimants submits that this Court, by order dated 05/02/2026 in First Appeal No. 2765 of 2009 and another connected matter arising out of the same acquisition, for the same purpose, and under the same Section 4 Notification, has granted compensation at the rate of Rs. 9,605/- per Are. He submits that the notifications are of the same period, the project is identical, and the lands are similarly situated.



3. It is further submitted that the only distinguishing feature between First Appeal Nos. 2765 of 2009 and 2766 of 2009 and the present matters (arising from LAR Nos. 831 of 2006 and 832 of 2006) is that the lands in the present case are of better quality and fertility, as observed by the Reference Court. He submits that the lands were not classified as *Bagayat* only on account of absence of wells and irrigation facilities. However, considering their quality and fertility, the lands deserve to be treated at least on par with semi-irrigated lands, as they cannot be termed as barren lands.

4. Per contra, the learned AGP submits that the lands are classified as *Jirayat* lands and, therefore, compensation ought to be restricted as granted in First Appeal No. 2765 of 2009 and First Appeal No. 2766 of 2009.

5. Having considered the findings recorded by the Reference Court, particularly in paragraph No. 9, it is observed that the acquired lands are of good quality and fertility. The same lands are shown to have been under cultivation at least in the rainy season, as deposed by the witnesses of the claimants. In view of the same, it would be appropriate to treat the lands on a higher footing as semi-irrigated.

6. Considering that in First Appeal No. 2765 of 2009, compensation for *Jirayat* land has been granted at Rs. 9,605/- per Are, this Court deems it



appropriate to enhance the same by 40%, thereby fixing the compensation at Rs. 13,447/- per Are. In First Appeal No.2812 of 2009, the land is already classified as *Bagayat* and higher enhancement is justified, thus the compensation is fixed at Rs. 17,289/- per Are (i.e., 80% increase). The claimants shall be entitled to all statutory benefits, which shall be worked out accordingly.

7. The claimants are permitted to withdraw the amounts deposited in the Reference Court. The balance amount shall be deposited by the State within a period of eight weeks from today.

8. The appeals filed by the claimants are disposed of in above terms. The appeals filed by the Acquiring Body stand dismissed.
