1. Except Advocate for petitioner in petition at Sr.No. 110, none remained present in the remaining listed petitions. The present Review Application/Writ Petitions came to be listed for the third time on the board of Registrar (Judicial). All the matters came to be filed between the year 2022. However, no steps appears to have been taken to remove the office objections. It is necessary to state here that these matters were listed on the board of Registrar (Judicial) for the first time wherein two weeks time was granted for the purpose of removing office objections. Subsequently, having not taken any steps, the matters were again listed for the second time and even at this stage, no steps were taken to remove the objections. Eventually, in the interest of natural justice, one more week time was granted for the said purpose. In totality, three weeks time was granted till today. However, the

applicant/petitioners appear to be not keen to remove the office objections and proceed with these matters. In these circumstances, fitness of thing requires refusal of registration instead of keeping these matters pending without any steps been taken. However, instead of passing any stringent order outrightly, I am of the considered view that in the interest of natural justice, one more opportunity needs to be given, which opportunity cannot be without any condition and I therefore, pass following order.

ORDER

Two more weeks time is granted to remove the office objections. It is also made clear that on failure on the part of applicant/petitioners to remove the office objections within stipulated period of two weeks as stated herein, the registration of the said Review Application/Writ Petitions shall stand automatically refused without any further reference to the Court of Registrar (Judicial).
