PER COURT :-

1. It is submitted by the learned Advocate for the Applicants/claimants submits that the AGP can appear for Respondent No.3.

2. The learned AGP appears for Respondent No.3 i.e. Executive Engineer, Minor Irrigation Department (Local Sector), Division Osmanabad. Hence, no need to again issue notice to Respondent No.3 which was earlier issued and due to non supply of the copy, notice was not served on Respondent No.3.
