**PER COURT :-**

**Civil Applications for Delay in preferring Cross Objections  
in Sr. No.909, 915, 916, 917, 918**

1. The applicants seek to condone delay in preferring cross objections.
2. For the reasons stated in the applications, delay is sought to be condoned.
3. The applications are contested by the respondents/ acquiring body. There is no reason to infer any malafides on the part of the private claimants in preferring cross objections/appeals belatedly. The acquiring body has also preferred appeals challenging self-same judgments and awards



passed by the Reference Court. It is desirable to condone the delay. As the delay is of smaller length, it can be condoned without imposing any condition. The delay stands condoned.

4. Civil applications for delay in preferring cross objections are allowed.

### **First Appeals and Remaining Matters**

5. After considering the submissions of the parties, this Court has to decide the manner and the methodology to decide the appeals. It is informed that rates are fixed village wise. The acquiring body as well as claimants have filed appeals challenging judgments and awards of the Reference Court. Appeals can be classified village wise so that it would be convenient to decide those appeals and to have the consistency also.

6. The learned counsels appearing for the private parties have shown their readiness to share the village wise list with the counsels appearing for the acquiring body. It is expected that there shall be co-ordination amongst the counsels for preparation of list of appeals village wise. The final village wise list shall be tendered by learned DSGI Mr. Talhar to the



Office so as to facilitate the office to list the matters village wise.

7. The Office shall list the matters village wise as per the list submitted by the acquiring body. It is expected that the list shall be comprising of appeals preferred by the acquiring body as well as private claimants in respect of the matters arising out of the particular village.

8. The parties shall be at liberty to keep private record or paper book ready to substantiate the submissions.

9. The village wise list shall be submitted by the acquiring body to the Office by 25.03.2026. Thereafter, Office shall list the matters village wise in accordance with the list on 30.03.2026.

10. Matters shall be listed on 30.03.2026 first on board.
