**PER COURT:-**

1. Heard the learned counsel for the applicants/appellants.
2. The learned counsel for the appellant submits that appellant has a good case on merit. The compensation awarded to the appellant is exorbitant and without considering the factors enumerated in the law. However, to show *bonafide* the appellant is ready to deposit the compensation amount.
3. In view of the fact there shall be ad-interim stay to the impugned judgments and awards on the condition to deposit 100% amount of the compensation within 12 weeks from today.
4. It is clarified that there shall be no extension.
5. If the amount is not deposited within 12 weeks from today the interim stay to the impugned judgments and awards should be vacated automatically without reference to the Court.
