2. The petitioner is a student of B.H.M.S. Degree Course at respondent No.4-Panchasheel Homoeopathic Medical College run under respondent No.3-National Commission for Homoeopathy. The contention is that the petitioner was admitted to B.H.M.S. course in respondent No.4-College in the year 2015, however the petitioner could not complete his course within the stipulated period of eleven years as provided under Rule 3(iv) of the Central Council of Homoeopathy Notification issued by respondent No.3.

3. Shri Ved Deshpande, learned counsel submits that in view of the aforesaid Rules, examination form of the petitioner is not being accepted and his name has been removed from the rolls of the college and hence the present writ petition.

4. Our attention is invited to the communication dated 25/02/2022 issued by the National Commission for Homoeopathy thereby granting additional chances to the students for clearing their examination during year 2020 and 2021 in view

of COVID-19 pandemic.

5. In view of above, issue notice to the respondents, returnable on 19/06/2026.

6. Shri N. S. Autkar, learned Assistant Government Pleader waives service of notice on behalf of respondent No.2.

7. The petitioner is permitted to serve the remaining respondent/s by private mode, in addition to the regular mode of service and file an affidavit by next date, failing which the petitioner shall deposit costs of Rupees Five Hundred with the 'Public Welfare Account' bearing No.129712010001014, IFSC Code UBIN0812978, Union Bank of India, Branch High Court, Civil Lines, Nagpur.

8. In the mean while, respondent Nos.1 and 4 are directed to accept the examination form of the petitioner for the ensuing examination to be conducted on 27/06/2026. It is made clear that acceptance of such form is subject to result of the present writ petition and in case if the petitioner fails in the present writ petition, he will not claim any equity in view of the aforesaid interim order.

9. Office objections(s), if any, shall be removed before the next date.
