2. Issue notice to the respondents, returnable on 30.03.2026.

3. We, however, note that the petitions were filed in the year 2018 and no attempt was made by the petitioners to get the petitions circulated for hearing. This aspect will be considered in due course.

4. Learned Addl. G.Ps./AGPs waive notice for respondent No. 1 however they have shown inability to waive notice for respondent No. 2 – Tapi Irrigation Development Corporation, through its Executive Director, Akashwani Chowk, Jalgaon (Khandesh),

through President, Paryawaran Vishayak Lokasunawani Samiti and Deputy Collector, Buldana, Dist. Buldana.

5. Since, respondent No. 2 is acting through Deputy Collector, Buldana, we request learned Addl. G.Ps/AGPs to take instructions and file reply. At the same time, we caution petitioners to be careful in describing the parties and eventually if it is found that respondent No. 2 is not correctly described, we will pass further order about the petitioners' ability/inability to prosecute the matters against correct party.

6. At this stage, counsel for petitioners seeks permission to amend the description of respondent No. 2.

7. We permit the amendment, however, the counsel should have been careful and made such request before commencing the argument.

8. Thus, right from filing the petition till today, casual and negligent approach continues. Nonetheless, party should not suffer for the mistakes committed by the counsel. We, therefore, grant further time to the petitioners' counsel to correct the title clause. Amendment be carried out forthwith.

9. Service to respondent No. 2 is also permitted through the Standing Counsel.
