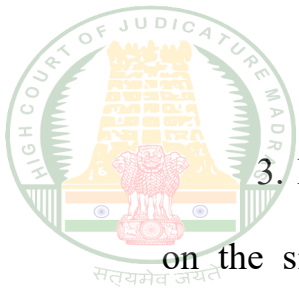

JUDGMENT
