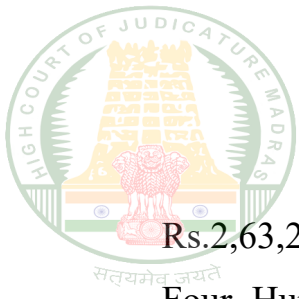

ORDER

The plaintiffs have filed the present appeal aggrieved by the judgment and decree dated 02.01.2025 passed by a learned Single Judge in C.S.No.894 of 2005, wherein the suit was decreed with respect to past mesne profits which had been quantified in the decree at Rs.36,22,500/- and towards the future mesne profits it had been quantified at Rs.2,26,97,919/-, on the date of the decree. The defendants have not filed any appeal challenging the same. However, the plaintiffs have filed the present appeal seeking enhancement.

2.A direction is issued to the respondents / defendants to deposit the total amount quantified in the decree, which is Rs.2,63,20,419/-, to the credit of C.S.No.894 of 2005 on the file of this Court, on or before 20.03.2026 and on such deposit, the Registry may transfer the same in an interest earning fixed deposit account, in any Nationalized Bank and if application is filed for



payment out, the Registry may recall the fixed deposit. The said amount together with accrued interest may be paid to the 3rd plaintiff / Skanda

Sundaram dispensing with issuance of notice to the respondents.
