ORDER

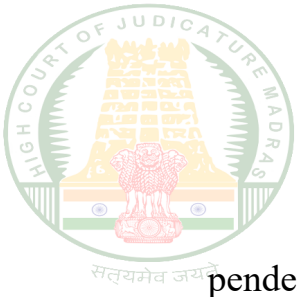

5. This Court is not expressing any opinion on the merits of the petitioner's representation.

6. For the foregoing reasons, this Court directs the 4th respondent to pass final orders, on merits and in accordance with law, on the petitioner's representation, dated 13.10.2025 seeking for cancellation of patta Nos.3511 and 3602 issued by the 5th respondent during the

pendency of the civil suits, after giving due consideration to the supporting documents filed by the petitioner and after hearing the objections of the respondents 6 and 7 or any other third party, whom the 4th respondent deems fit to enquire, within a period of twelve (12) weeks from the date of receipt of a copy of this order.
