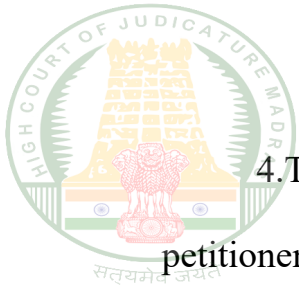
ORDER

4. This Court is not expressing any opinion on the merits of the petitioner's representation.

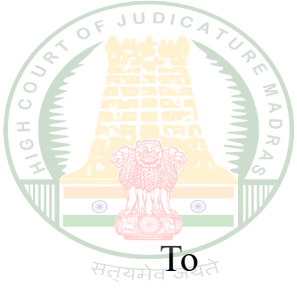

For the foregoing reasons, this writ petition is disposed of by directing the first respondent to pass final orders, on merits and in accordance with law on the petitioner's representation dated 11.12.2025 seeking for survey and sub division of the property, morefully described in the prayer to this writ petition and for issuance of separate patta in his name, after giving due consideration to the supporting documents filed by the petitioner and after hearing the objections if any from the neighbouring land owners as well as any other party whom they deem it fit to enquire, within a period of 12 weeks from the date of receipt of a copy of this order.
