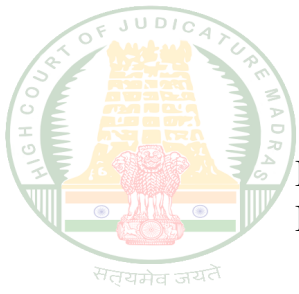

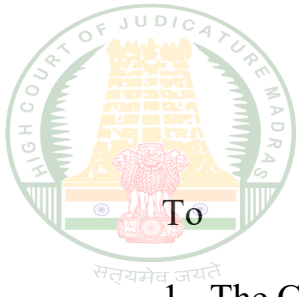
3. The learned Counsel for the petitioners would submit that respondents have not complied with the said order of this Court dated 11.03.2026.
