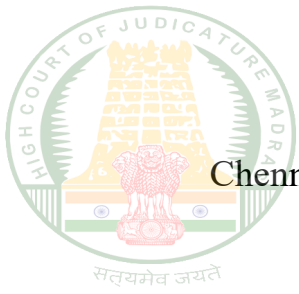

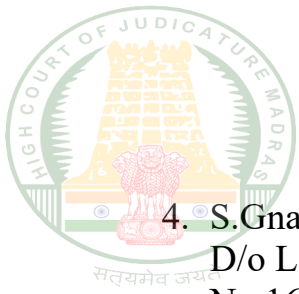

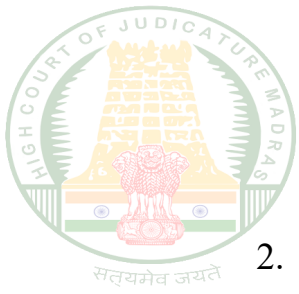

After a brief hearing of the learned counsel on either side and having regard to the nature of the dispute, this case is referred to mediation attached to this Court.

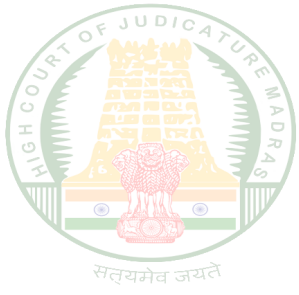


2. As chosen by the learned counsel for both sides Ms.Kavitha Balakrishnan is appointed as mediator. All the parties, along with their respective learned counsel, are directed to appear before the Mediator, Tamil Nadu Mediation and Conciliation Centre, High Court of Madras on 04006.2026 and the Mediator shall hold appropriate sessions with the parties, explore the possibility of an amicable settlement of the inter se disputes, and facilitate the parties in arriving at a mutually acceptable resolution and the parties are also permitted to appear before the Mediator in Video Conference subject to the directives of the Mediator. The fees and expenses of the mediator shall be borne by both the parties as will be fixed by this Court in the next hearing.

3.Registry is directed to list the matter on 18.06.2026 along with the mediation report under the caption mediation referred cases.
