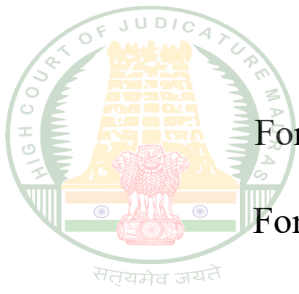

Recording the same, this writ petition is disposed of. No costs. Post the matter on 21.04.2026, for reporting compliance of payment.

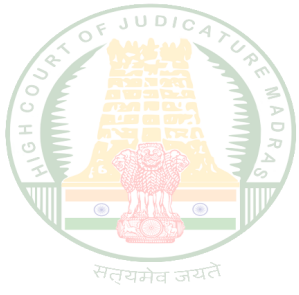
