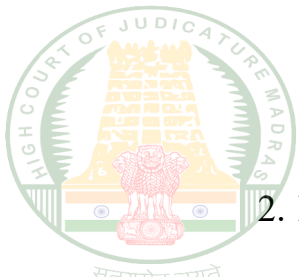

No.3005/2005/E2 to the post of chief cane development officer in the second respondent corporation by the second respondent following the principle of reservation by communal rotation by advertisement notification issued in the English news daily Indian Express dated 01.12.2005 is illegal unconstitutional and void abinitio and further declare the regularization of the fourth respondent in the services of chief cane development officer by the second respondent is null and void and unconstitutional and direct the second respondent to fill up the single cadre post of chief cane development officer on selection merit basis by direct recruitment without adopting the policy of reservation forthwith.
