ORDER

Both the husband and wife filed petitions for permanent custody of the minor children and many applications are before this Court seeking various directions. It augurs well for the parties to appear before the mediation centre.

2. After a brief hearing of the learned counsel on either side and having regard to the nature of the dispute, both parties, along with their



respective learned counsel, are directed to appear before the Tamil Nadu Mediation and Conciliation Centre, High Court of Madras, Chennai along with their child/children directly on 28.03.2026 and participate in mediation.

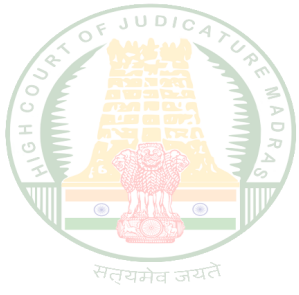
3.The Mediator namely Dr.T.Ramasamy along with Ms.Manimegalai, Child Counsellor, shall hold appropriate sessions with the parties, explore the possibility of an amicable settlement of the inter se disputes, and facilitate the parties in arriving at a mutually acceptable resolution. In the event of a settlement being arrived at completion report shall be submitted before this Court.

4.If no settlement is arrived at between the parties, Ms.Manimegalai, Child Counsellor shall submit to this Court a report setting out a feasible parenting plan, bearing in mind the paramount welfare of the child/children. The fees and expenses of the counsellor shall be borne by both the parties as will be fixed by this Court in the next hearing.

5. Registry is directed to list the matter on 17.04.2026.

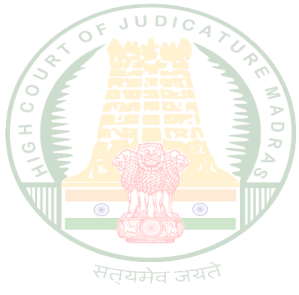
